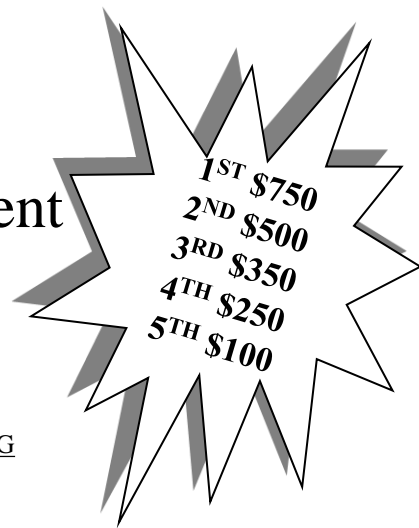

1. All state and federal rules and regulations must be observed. (Including Slots)
2. Winners may be subjected to a polygraph test.
3. Fish must be caught on artificial lures (No trolling).
4. Largemouth and Kentucky spotted bass only.
5. Tournament director's decision will be final in all matters.
All protest must be in writing within 30 minutes of final weigh-in.
6. Fish must be alive to be weighed in.
7. Anglers may win more than one hourly big bass, but only one big bass per contestant for grand prize.
8. Only 3 bass may be weighed during tournament.
9. Ties will split winnings and position.
10. 16 inch minimum length on all fish weighed.
11. Only one bass per hour per contestant.
12. NO alcoholic beverages allowed.
13. Life jackets must be worn when big engine is running.
14. All grand prize winners must attend presentations.
15. Angler must be in weigh in line by 2:00 p.m.
16. All fish weighed become the property of the LR Chamber of Commerce.

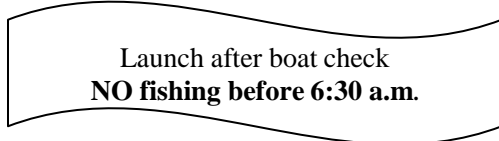

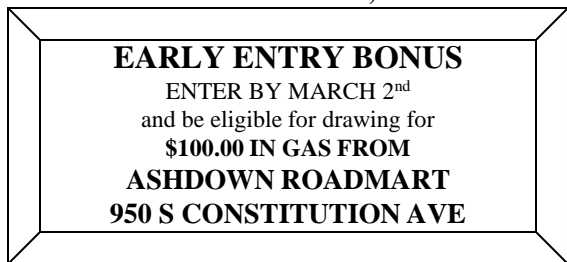
