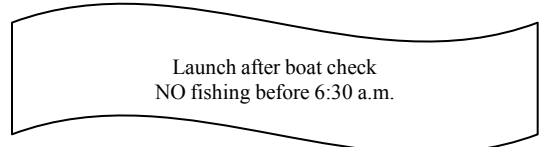

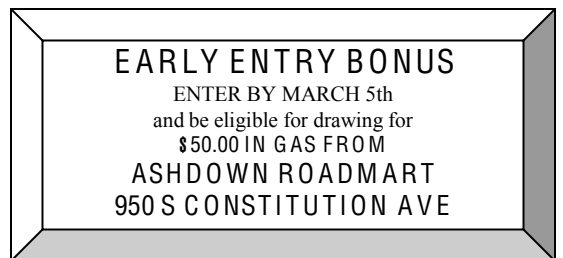
RULES

- Only 3 bass may be weighed during tournament.

- 16 inch minimum length on all fish weighed.
- Only one bass per hour per contestant.
- NO alcoholic beverages allowed.
- Life jackets must be worn when big engine is running.
- All grand prize winners must attend presentations.
- Angler must be in weigh in line by 2:00 p.m.
- All fish weighed become the property of the LR Chamber of Commerce.
